Organizational units should complete this form and submit it with or attach it to any Personal Services Contract, Limited Services Engagement Form, Non-UC-Student Scholarship/Fellowship form or Royalty Payment form for which the payee is *neither* a US citizen *nor* a Lawful Permanent Resident (green-card holder). It is the responsibility of the sponsoring organizational unit to ensure the visitor has an appropriate immigration/visa status that allows for payments. This form should be completed by the visitor **prior to** engaging in the agreed-upon activities. The sponsoring organizational unit should contact UC International Services with any questions about UC's ability to pay honoraria or other amounts to this visitor. If the visitor is eligible for tax treaty benefits and does not have a US Social Security Number or Individual Taxpayer Identification Number (ITIN), the visitor will need to schedule an appointment with UC International Services during their visit at UC. Failure to do so will result in up to 30% tax withholding.
