2 What is LATEX?

LATEX is a markup language and document preparation system.

Advantages: sharper presentation, more control over formatting and positioning of tables, mathematical symbols, equations, and graphs. It can also be used for a wide range of documents, from posters and presentation slides to articles and even books.

Disadvantages: higher learning curve.

3 Getting Started

Here are some resources to get LATEX onto your computer and help for once it is up and running.

3.1 Essential components

You need two things to start using LATEX: the distribution—software that takes the code/text you write and makes it into a document—and a text editor for creating that code.

4 First Steps

To begin, open TeXnicCenter and save a new document. By typing in LaTeX, you can control everything from the spacing of your document to the style of your tables to the (automatic) generation of your references. At a minimum, you will need to use the following typesetting commands to compile your document.

```
\documentclass[12 pt]{article}
\begin{document}

Start typing here
\end{document}

Notice the basic LATEX syntax of writing a command: \command[<optional arguments>] {<text>}.

- \command what you want LATEX to do
- [] square brackets for optional arguments
- { } curly brackets for the main argument or text

4.1 The Preamble

In a real document, you will put all introductory commands that control the general layout of the paper together at the beginning of the document in a section referred to as the "preamble". These commands are calls to packages that affect the document's layout, styles, and so forth. This document, for example, was created using the preamble listed below. At this point these particulars are not nearly as important as the general lesson: you have control over the basic appearance of your documents and much of it is established by the packages you invoke in the preamble. Then TeX's typesetting algorithms take commands from those packages and those that you type to make the document.

5 Creating an Article

5.1 The preamble, title, and abstract

Let's make an article!

```
\documentclass[12pt, letterpaper]{article}

Now our document needs a title, author, and date. Notice the use of double backslashes $(\setminus \setminus)$ to end the line with a hard return.

Now we need to actually start the document. This is done with the \begin{document} command and is followed by the \maketitle command, which tells TeXto put the title/author/date information that we typed above into our document. You should also type \end{document} a few lines down. After that, you can make an abstract:

5.2 Section headings and paragraphs

There are three levels of section headings available: \section{<text>}, \subsection{<text>}, and \subsection{<text>}. To remove the numbering from any of these, type an asterisk after the word "section," as in \subsection*{<text}.

5.3 Page numbers

To remove the page number from the title page, type \thispagestyle {empty} after your abstract.

To change where the page numbers are located, you need to add the following code to the preamble. The command \rfoot {\thepage} sets where the number goes. Change it to 1 for left and head for the top of the page.

For different types of page numbers, use the \pagenumbering{} command in your preamble (or where you want the numbering to be styled in that way).

\pagenumbering{roman} % Lowercase roman numerals
\pagenumbering{arabic} % Arabic numerals (default)

5.4 Special characters

In LaTeX, several characters have special meaning for programming purposes. Some examples are: & separates columns in tables, \$ starts a math environment, % starts a comment, and \ precedes nearly any active command. If you want to include one of these characters in your text, LaTeX needs a signal that this is how you want to use the character. The code to include these characters as well as other tricky characters, is listed below:

5.5 LATEX Environments

LATEX offers several "environments," each of which gives TEX specific formatting instructions. We have used a few already. Every environment begins and ends in the same manner:

5.5.1 Bulleted Lists

Creating a bulleted list requires the following environment:

\begin{itemize}
\item Item \#1
\item Item \#2

Which gives:

- Item #1
- Item #2

• Item #3

By including a character in square brackets after \item, then we can use any kind of bullet we like. See http://www.ctan.org/tex-archive/info/symbols/comprehensive/symbols-a4.pdf. For example, \item[\$\circ\$] will place an open circle in place of the bullet. Text can also be a bullet, as in \item[A] \#1. If you want the list to be numbered, use the enumerate environment.

Also, you can nest lists up to four times. Just remember you have the same number of occurrences of \begin { } as \end{ }. In these cases, it might help you to organize the list by indenting each nested list.

5.6 Fonts

You can change several aspects of the font, including the family, type, size, and color.

5.6.1 Font family

Visit this link: http://www.tug.dk/FontCatalogue/ to see the fonts available in TEX. Clicking on each one will give preamble commands to use the font. Note that not all fonts available with TEX are available with PDF, so some might cause errors.

5.6.2 Font type

Several font types are available:

5.6.3 Font size

Font size commands depend on what the default font is for your document. You can set this in the first line of the .tex file: \documentclass[12pt, letterpaper] {article}. If you do not specify an option, 10 point is used. To increase or decrease font size, use one of the following commands:

These commands can be used as an environment or with curly braces (e.g., \footnotesize { <Text>}).

5.6.4 Font color

Font color is changed with the color package (add \usepackage{color} to your preamble). For more color options as well as the ability to change color within a table, you can also add \usepackage[usenames, dvipsnames, svgnames, table] {xcolor} to the preamble. The command \textcolor{<name of color>} {<Text you want in that color.>} will change the color of text. To see more details on available colors, see http://en.wikibooks.org/wiki/LaTeX/Colors.

5.7 Footnotes and endnotes

Footnotes are created by the \footnote{} command. For example, take a look at the bottom of this page. If you would like to use endnotes, insert the following into your preamble:

Then, use the \footnote{} command as usual, but insert the command \theendnotes at the point where you would like the endnotes to start.

5.8 Spacing and block quotes

With the setspace package loaded, you can change spacing within your document. If you want a doublespaced document, type \doublespacing after \maketitle or the Abstract. If you would like to switch to single or one-half spacing at some point, use the commands \singlespacing and \onehalfspacing. You can also use these commands as environments, as in

To make a block quote, use the quote environment.

6 Floats

Floats are objects that go in your document but are not part of the main text, such as tables and figures. The main aspects to control are the content of your float, and its size and placement in the document.

6.1 Tables

You can create a table with two different environments: tabular, which handles the structure and content, and table, which handles the labeling, placement, and other descriptive aspects. Let's start with the following code using tabular:

6.2 Figures

With the graphicx package you can insert a wide variety of files to use as figures such as .pdf, .eps, .jpeg, and others. Similar to tables, two commands are used to create a figure. The \includegraphics {} command calls the file into your document and the figure environment is used for placement, captioning, etc.... Just make sure the file is in the same folder as your .tex file. Here is an example:




Figure 1: The First Figure

You can also put two (or more) graphic files together in one figure and have a caption for each with the subfig package:




Figure 2: Two Graphics in One Figure

6.3 Float placement and rotation

Float placement is governed by an optional argument after you type \begin{table} or \begin{figure}. You type square brackets and a letter: h for exactly where the code is t for top of the next page, b for bottom of this page, and p for a dedicated page of floats. For example, \begin{table} [h] will try to place your table where you insert the code.

However, this does not always work as well as it sounds. Sometimes the structure of the document makes it so that TeX will put the table in odd places. One solution is to use the float package. This contains the argument [H], which goes in the same place as [h]. This overrides TeX's figure defaults and puts the figure exactly where the code is located.

You can also rotate floats if they fit better sideways with the rotating package. This is done exactly as above, except you use the environments sidewaystable or sidewaysfigure. Here is an example:

Which produces the two figures on the next page (because of fit).

6.3.1 Placing floats at the end of the document

Many journals want submissions with figures and tables at the end, each on a separate page, and with some text indicator showing where each float goes. This can be accomplished easily with the endfloat package. With that package in your preamble, remove the [h] or [H] options and simply place your floats where they fall in the document. TeX will then place "[Figure 1 about here.]" in that place, and the figure (or table) will go to the end. If you want to change this text, insert the following code in the preamble, making any changes where appropriate:

6.4 Referencing floats in text

One very helpful aspect of writing in LATEX is the ability to make reference to floats. Notice that we used \label{} to name each float. When we want to refer to that float in text, we use the \ref{} command. For instance, to refer to the table above—type the following:

As you can see in Table \ref{Multicolumn}, the results support my hypotheses.
```

This produces:

As you can see in Table 2, the results support my hypotheses.

You can label many things: sections/subsections/subsubsections, footnotes/endnotes, itemized lists, etc.... I strongly recommend using this feature. It is helpful if you ever change the position of the labeled object because the reference will adjust accordingly. For instance, if you label a footnote and refer to it, then delete the footnote appearing before the labeled one, the counter will update to match.




Figure 3: Two Sideways Graphics in One Figure

7 Mathematical Expressions

The math environments in LaTeX expect different syntax than the regular text-processing environments. You can write in math in four ways: in-line text, the equation environment, the equation environment, and the array environment. There are lots of different symbols you can make. Take a look at TeXnicCenter's drop down menus for examples.

The easiest call to the math environment, in-line text, starts and ends with a \$. Hence, x^2 returns x^2 , or y_i returns y_i . Normally, this environment will try to cram your equation into the normal space of a text line. For example, try the the summation command: $\sum_{i=1}^{n} \{x^2\}$. If you prefer, though, you can use the \displaystyle command: this makes the equation look sharper, but adds whitespace before and after the line to make room. See how the summation looks with this option: $\displaystyle \sum_{i=1}^{n} \{n\} \{x^2\}$ \$.

A second option that we have is to use the equation environment. Notice that equations can be labeled and referenced just like floats.

```
\begin{equation} $$ \left(z \times x^3\right) = 3z \times x^2\left(derivative\right) \\ end{equation} \end{equation}
```

$$\frac{\partial}{\partial x}(z \times x^3) = 3z \times x^2 \tag{1}$$

Typing \begin{equation*} will suppress the equation numbering, but requires the amsmath package to be loaded. A third option is to use the eqnarray environment. This syntax also illustrates how to write Greek letters and another way to suppress equation numbering.

```
\begin{eqnarray} $$ \left( x \le \frac{1}{\sqrt{2\pi^2}} \exp(\frac{-(x-\mu)^2}{2\pi^2}) \right) $$ \left( x \le \frac{1}{\sqrt{x} \cdot \frac{2\pi^2}} \right) $$ \left( x \le \frac{1}{\sqrt{x} \cdot \frac{1}{x} \cdot \frac{1
```

Which produces:

$$\phi(x) = \frac{1}{\sqrt{2\pi\sigma^2}} exp\left\{\frac{-(x-\mu)^2}{2\sigma^2}\right\}$$

$$\Phi(x) = \int_{-\infty}^x \phi(t)dt$$
(2)

Notice that the symbol formats the first column right-justified, the second centered, and the third left-justified. This makes it easier to line-up the equations.

As a final example, let's create a matrix using this code:

```
\[ \left[
\begin{array}{ccc}

Which produces the matrix shown below. The only optional parts of this code are \left[and \right], which control what symbol will surround the matrix.

$$\left[\begin{array}{ccc} a & b & c \\ d & e & f \\ g & h & i \end{array}\right]$$

8 Automatic Citations

LATEX will create citations and a reference page for you. There are a few ways to do this, but I think the best is through the natbib package. To set it up, first add \usepackage{natbib} to your preamble. Next, you need need a file with citations in it. We will use the file sample.bib for this purpose. Place that in the same folder as you .tex file, or include the complete path to the file in the { }. I recommend using JabRef (available free at http://jabref.sourceforge.net/) to manage this file. Open sample.bib in JabRef to see how to add entries to your bibliography file. Notice that one line you need to define is the name for that citation that you will use in your .tex file. I generally follow the convention <first author's last name><year>.

Finally, you need a .bst file which tells TEXthe citation style you would like to use. In this case, we will use apsr.bst (*American Political Science Review*). Like with sample.bib, place these in the same folder as you .tex file, or include the complete path to the file in the { }.

With these files in place, add the following code just before \end{document} in your .tex file:

```
\bibliographystyle{apsr}
\bibliography{sample}
```

The natbib package contains a number of ways to cite something from your .bib file. See http://merkel.zoneo.net/Latex/natbib.php for all the available options. Also, that reference sheet shows how to use the \bibpunct{} command to set the punctuation you want with citations. Here are some examples. Hyperlinked citations come from using the hyperref package, though be careful because this package is notorious for producing errors. If you want to use hyperref, make sure it is the last package you load in the preamble. Also, you have to compile the document three times to get a new citation to appear.

- \citep{Alden01} \rightarrow (Alden 2001)
- \citet{Alden01} \rightarrow Alden (2001)
- \citep{Bercovitch91} → (Bercovitch, Anagnoson, Wille and Barro 1991)
- \citep{Bercovitch91} → (Bercovitch et al. 1991) [second time uses "et al."]
- \citep*{Bercovitch91} → (Bercovitch, Anagnoson, Wille and Barro 1991) [back to the full author list with the *]
- \citep[][]{Beardsley08, Alden01, Barro05} \rightarrow (Beardsley 2008; Alden 2001; Barro and McCleary 2005)
- \citep[][104]{Beardsley08} \rightarrow (Beardsley 2008, 104)
- \citep[see][]{Beardsley08} → (see Beardsley 2008)
- \citep[e.g.,] [but see \citealt{Alden01}] {Beardsley08} \rightarrow (e.g., Beardsley 2008, but see Alden 2001)

Finally, there are many options for natbib in the preamble, which are called with square brackets. For instance, \usepackage[longnamesfirst] {natbib} will write out all of the authors in a citation with four or more authors the first time, then use "et al." after that.

9 Creating a Slideshow

There are several packages available to make presentation slides in LATeX, with the most common being the beamer class. The first thing you need to do is specify the document class as beamer, then set the theme with the usetheme $\{\}$ command. We will use the Warsaw theme here, but there are many more (see http://latex.simon04.net/). Then you put in your title and name in the standard way. Also, the \institute{} argument allows you to place your affiliation on the title slide.

```
\documentclass{beamer}
\usetheme{Warsaw}

Each slide is created with the frame environment. The first two frames you will want to make are the title slide and a slide with an outline of the presentation. This is done with the \tableofcontents command (which also works in articles). This command organizes your sections/subsections/subsections into a table of contents.

```
\begin{document}

To make substantive slides, use \section{}, \subsection{}, and \subsubsection{} like usual, and invoke the frame environment each time you want a new slide. To create a title for the slide, use \frametitle{}. Generally information is presented in bulleted lists. If you would like each bullet point to appear in sequence, use the <#-> format:

Finally, to make references work, you need to do some lower-level TeX programming (for one line of code). Make sure you have \def\newblock{} before the bibliography lines.

10 Creating a Poster

One of the strongest (in my opinion) features of LATEX is its ability to make scientific posters relatively easily. This is done with the sciposter class. Below are some basic commands to get one started, but take a look at the package manual (http://mirror.unl.edu/ctan/macros/latex/contrib/sciposter/scipostermanual.pdf) to see all of the options. Here is a sample preamble:

Next, you need to add title and author information. In addition, you can put a logo in the left (and/or right) corner:

Then to break up the content into columns, use the multicols { } command. Once this is used, you add content in the normal way, including text, figures, tables, footnotes or endnotes, and references.

11 Generating New Commands

Sometimes you will find that typing LaTeX commands can be burdensome. 12 Some More Commands

Here are a few more commands that can be useful.

- To write out URLs: call the package url, then type \url{www.urlgoeshere}.
- To write in ASCII text: use the verbatim environment or "for inline text.
- To get a two-column document: use the command \twocolumn in the preamble. If you want only a small part to be two column, call the \multicol{} package. This allows you to use the multicols environment like when making a poster:

13 Searching for Features: Some Examples

13.1 Making a CV

LATEX can do a lot of things and the best way to explore its capabilities is online. I recommend starting any search with "latex," then a description of what you want to find. Here is an example. Let's say you want to find out how to make a CV in LATEX. The Google search "latex create a cv" produces several results in the first few hits that have LATEX code you can copy and paste into TeXnicCenter. Once you find one that you like, it is simple enough to fill in your own information.

13.2 Writing a cover letter

Now let's say you want to write several cover letters in LATEX. This can be a big task because each one goes to a different job, but you want to make sure it is done correctly. Googling "cover letters in latex" produces http://www.zaphu.com/2007/12/07/automated-cover-letters-in-latex/, which can help. The basic idea is that you create one document with the content of the letter, then a separate document that defines the information for one job, fills that information into the letter, then moves on to the next job.
