- Explore causes and outcomes of 2008 crisis with Multiple Indicator Multiple Cause model.
 - Includes over sixty potential causes of the crisis in 107 country sample.
 - Unable to link most of the commonly cited causes of the crisis to its incidence across countries.
 - Raises doubt about potential accuracy of "early warning" systems for financial crises.
 - Early warning models must also predict timing of crises, which is even more difficult.
