Steps to Register

For non-matriculated students (students who wish to take classes for credit without being enrolled in a degree program)



1. Complete this Basic Data Form in its entirety.

- In-person to the One Stop Student Service Center, 2nd floor, University Pavilion, Uptown Campus or to the registration center at the campus (UC Blue Ash College, UC Clermont College) where you intend to take classes.

3. Give us a few days to establish your access to online student services.

This will take approximately two (2) business days from the date the form was received. You will be contacted by email with your Username and UCID. You will use your username and password to access all One Stop Student Services online. Your UCID is used for both academic and administrative purposes to ensure that you are correctly identified. The UCID will be used on exams, Scantron exams, Bluebook submissions and term papers, at the One Stop Student Service Center in University Pavilion, by your college office or any other UC office with which you do business.

4. Register/add/drop classes.

With your Username and UCID, you are ready to register online. You can register any time during Open Registration for the term in which you wish to take classes.
