

Truffer Installed as MSBA President

Baltimore County Circuit Court Judge Keith R. Truffer was installed as the 125th President of the Maryland State Bar Association (MSBA) on June 16, 2018, at the close of the MSBA Legal Summit & Annual Meeting. Truffer will lead the roughly 24,000-member Association for the next 12 months.

Truffer, a Baltimore native, opened his 20-minute address by describing his own professional journey, from the University of Baltimore School of Law to his more than three decades with the Towson law firm of Royston, Mueller,

McLean & Reid, LLP and, ultimately, his January 2016 appointment to the Baltimore County Circuit Court bench, before moving on to his priorities for the Association in the coming bar year.

"As you know by this time, the MSBA is undergoing a period of extraordinary change," said Truffer. "During the upcoming year, we want to build upon and accelerate the great strides we have initiated to secure the near and long-term health of the Association."

Instrumental to that health is a thorough review of MSBA's governance policies, some of which, he noted, date back to the Association's founding in 1896. To address this need, Truffer announced the appointment of a brandnew Policy Review Committee, which will "undertake a comprehensive review of the MSBA's policies and practices, conduct research into and a comparison with the best practices in our industry and, ultimately, recommend such changes to our bylaws as are necessary to implement these best practices."

"In this way," he continued, "we can create a structure which best positions MSBA to meet the new challenges we face and take advantage of the new opportunities presented."

Looking ahead, Truffer voiced a need to also "be mindful of those challenges and opportunities which are on and beyond the horizon."

"We need to establish long-term priorities to guide our policies from year to year," he added. "We must make ourselves more anticipatory, and less reactive." To this end, he announced plans to create "a Strategic Vision Committee with a long-term focus and a broad vision to plot a course for the MSBA over the next five to 10 years."

"This Committee will define the MSBA's continu-

United States Reaches 10 Millionth Patent Milestone

The U.S. Patent & Trademark Office ("USPTO") reached a milestone on June 19, 2018 by granting U.S. Patent No. 10,000,000 entitled "Coherent LADAR [laser detection and ranging] using intra-pixel quadrature detection" to Raytheon Company. The occasion was marked by a White House ceremony, at which President Donald J. Trump, Secretary of Commerce Wilbur Ross, and USPTO Director Andrei Iancu signed the patent. According to the USPTO's website, the patent is further distinguished by being the first to receive a new patent cover design, which is only the second change to the patent cover to take place in the last 100

It has been over 180 years since the USPTO issued U.S. Patent No. 1 under its current numbering system to John Ruggles for a "Locomotive Steam-Engine for Rail and Other Roads" on July 13, 1836. (The first U.S. patent, not numbered under the USPTO's current system, was granted over two-and-a-quarter centuries ago on July 31, 1790 to Samuel Hopkins for an improvement in making pot ash and pearl ash. Mr. Hopkins' patent was likewise signed by the president at the time, President George Washington.)

One remarkable aspect of the

lead-up to the issuance of U.S. Patent No. 10,000,000 has been the accelerating rate at which patents have been granted over the years. It took about 75 years from the grant of Mr. Ruggles' U.S. Patent No. 1 in 1836 before U.S. Patent No. 1,000,000 was granted in 1911. The subsequent millionthpatent milestones occurred in the following years (with the number of years elapsed since the previous grant milestone in parentheses): 2,000,000 in 1935 (24 years from the grant of 1,000,000), 3,000,000in 1961 (26 years), 4,000,000 in 1976 (15 years), 5,000,000 in 1991 (15 years), 6,000,000 in 1999 (8 years), 7,000,000 in 2006 (7 years), 8,000,000 in 2011 (5 years), 9,000,000 in 2015 (4 years), and 10,000,000 in 2018 (3 years). Over 300,000 utility patents (not including design patents and plant patents) have issued over the past year. If the rate of patent grants continues to accelerate at its current pace, U.S. Patent No. 20,000,000 should issue in about 30 years, around (and likely before) 2050. That is approximately one-sixth the amount of 180 years it took to grant the first ten million patents.

U.S. Constitution is the basis for the grant of patents (and copyrights). Article One, Section 8, Clause 8, provides that "[t]he Congress shall have power ... [t]o promote the progress of science and times to authors and inventors the exclusive right to their respective writings and discoveries." patents laws are codified in Title 35 of the United States Code. Section 101 states that "[w]hoever invents or discovers any new and useful process, machine, manufacture, or composition of matter, or any new and useful improvement thereof, may obtain a patent therefor, subject to the conditions and requirements of this title." In addition to being "new and useful," an invention must be non-obvious to be patentable. The patent laws provide the

owner of the patent with a right to exclude others from making, using, selling, offering to sell, and importing the patented invention, and from inducing others and contributing to the infringement of a patent. This exclusionary right is granted for a limited period (now 20 years from the earliest effective filing date, with patent-term adjustments available in some cases and subject to payment of maintenance fees). In return, as a quid pro quo, the inventor must disclose to the public in the patent how to make and use the invention. In other words, the inventor must "spill" his or her secrets. The information disclosed by the inventor is shared with the public through the publication of patent applications and granted patents. This sharing allows the

public to build upon the invention, thereby speeding the progress of scientific endeavor.

Without the promise of exclusivity, inventors would be forced to turn to secrecy (trade secrets) as the best protection for their inventions. However, trade secrets cannot protect an invention that can be reverse engineered. Thus, it can be (and has been) argued that without the patent system, there would be less incentive for individuals (and the corporations, universities, and

governmental entities for which they work) to innovate. And without incentive to innovate, we likely would be nowhere near ten million granted patents or the technological revolution that our society continues to enjoy.



MSBA's Annual Business Meeting of the membership occurred June 16, 2018 during the 2018 MSBA Legal Summit & Annual Meeting at the Clarion Fountainbleau Hotel in Ocean City, Maryland. The Business Meeting featured a celebration of several achievements, including the graduation of the 2017/2018 Leadership Academy class, the appointment of the 2018/2019 Board of Governors, and the installment of the Hon. Keith Truffer as President of the MSBA. In addition, the members unanimously approved updated bylaws, which can be found on MSBA's website under the "About" tab.

In addition to the Annual Business Meeting of its membership, MSBA's Board of Governors ("Board") held two meetings; one on June 13, 2018 with the outgoing Board, and one on June 16, 2018, with the newly appointed Board.

The 2017/2018 Board has made tremendous progress implementing significant change at the MSBA, including upgrading infrastructure at the MSBA head-quarters, launching a new website, delivering over 300+ programs, CLEs, and networking events for MSBA members, and much more. 

Honoring Maryland's Pro Bono Heroes at MSBA Annual Meeting

Each year, during the annual MSBA business meeting in Ocean City, members of the Association pause to honor Maryland lawyers who have provided exemplary pro bono service during the previous year. Nominations for the Maryland Pro Bono Service Awards are collected each spring by the Pro Bono Resource Center of Maryland (PBRC), the pro bono arm of the MSBA.

On June 16, the 2018 awards were presented by Chief Judge Mary Ellen Barbera of the Maryland Court of Appeals, and Sharon E. Goldsmith, Executive Director of PBRC.

The Judge Robert M. Bell Award (honoring an individual who has gone above and beyond the average pro bono commitment for at least 5 years) was presented to Mary Anna Donohoe, of Montgomery County. Ms. Donohoe started volunteering with Homeless Persons Representation Project in 1988, staffing a clinic at a soup kitchen. She has volunteered once a month for thirty years, helping homeless persons with a broad swath of civil legal issues, including bankruptcy, consumer debt collections, employment, public housing, family law, and issues involving wills, trusts, and estates. Over her three decades as a volunteer, she has donated services with an estimated value of over \$158,000.

Charles Scheeler, senior counsel in the Baltimore office of DLA Piper, was selected for the Distinguished Pro Bono Volunteer Award (honoring an individual who has contributed in an outstanding way over a period of time or through extended service in a complex matter or case). Mr. Scheeler accepted the first vacatur case the Maryland Volunteer Lawyers Service (MVLS) Human Trafficking Prevention Project ever placed with a volunteer attorney. The case involved vacating 10 prostitution convictions for a survivor of human sex trafficking. Mr. Scheeler dedicated 7 months to the case, demonstrating sophistication in post-conviction law, and showing strong compassion and empathy in the representation.

The Retired Pro Bono Volunteer Award was awarded to Elva Tillman, of Baltimore City. Ms. Tillman has been volunteering with MVLS since 1992. Since her retirement from the Law Department for the City of Baltimore in early 2017, she has become a valuable addition to MVLS's Consumer Protection Project clinic. In 2017, she volunteered at 33 of the 52 clinics and assisted 72 clients. In addition, Ms. Tillman volunteers with Pro Bono Resource Center's Home Preservation Project.

The **Lee A. Caplan Award** (honoring a solo or small firm practitioner) was presented to Herbert A. Dubin of Mont-

gomery County. Since 2008, Mr. Dubin has provided over 1,400 hours of pro bono service, including helping 65 clients with family law cases. Mr. Dubin became a solo practitioner in 1983, and, at 77 years of age, brings a wealth of experience and a sense of balance as he serves clients and mentors newer volunteer attorneys.

Three immigration attorneys, Madonna Lebling, Christian Noble, and Maya Zegarra, were selected for the Young Lawyers Section Alex Fee Memorial Award. These three attorneys started out as University of Baltimore law student volunteers with Esperanza Center's Pro Bono Project. They consistently volunteered together at weekend legal clinics, and each has made an individual decision on how to serve with Immigration Legal Services. Mr. Noble signs up in January for an entire year of clinics; Ms. Lebling takes back-to-back pro bono clients to keep her skills sharp; and Ms. Zegarra acts as an ambassador, encouraging her membership organizations and colleagues to donate to and volunteer with the Pro Bono Project.

The **Law Firm Pro Bono Service Award** (honoring firms that innovate and encourage a significant percentage of the firm's attorneys to participate) was presented to Santoni, Vocci & Ortega, LLC, of Towson. In just over a year, the three members of this firm have accepted 34 consumer pro bono

cases from MVLS, and provided court-house counseling and services through PBRC and Civil Justice. The cases are both fast-paced and complicated, but these attorneys have accepted them without hesitation, often achieving advantageous settlements for their clients. Attorneys from the firm also help staff to unravel complicated legal issues, and assist by training and mentoring newer attorneys.

The Maryland Juvenile Lifer Parole Representation Project was selected to receive the Herbert S. Garten Special Project Award (honoring an individual, group, or firm that has initiated a special project that enhances the delivery of legal services for low-income persons). This working group includes Families Against Mandatory Minimums; the University of Baltimore Law School Juvenile Justice Project; Skadden, Arps, Slate, Meagher & Flom LLP; the Maryland Office of the Public Defender; the American Civil Liberties Union of Maryland; the Maryland Restorative Justice Initiative; the Catholic University of America Columbus School of Law Clemency Project; and the American University Washington College of Law Criminal Justice Clinic.

The parole process presents obstacles that prevent even model juvenile lifers from being considered for release. Legal representation is critical, but mostly unavailable. Since coming together in May 2017, the

group has recruited 50 pro bono attorneys, who are currently representing 28 clients. Present to receive the award were Professor Jane Murphy of the University of Baltimore Law School, Maryland Public Defender Paul B. DeWolfe, and Mary Price of Families Against Mandatory Minimums.

The **Non-Legal or Organizational Involvement Award** was awarded to Maryland Faith Health Network (MFHN). Understanding the impact that foreclosure, tax sale, and other housing instability has on the wellbeing of our communities, MFHN set about to provide knowledge and resources in these areas. They sought funding from the Maryland Department of Health to create presentations on advanced health care directives, to be provided through various places of worship. The project has created connections between faith leaders, who are often the ones consulted during life crises, and free services related to legal needs.

There's an App for That!

Through Form and Function, Apps are Making Lawyers More Productive

There are more than six million apps available to smart phone and tablet users today, with nearly two million in the Apple App Store, and 3.6 million in Google Play, according to statista.com. When you hear someone say, "There's an app for that," believe it. However, among them are only a select few that stand out from the crowd, perform the way they were intended, and receive excellent reviews.

Today's law-related app technology is aimed at improving the efficiency of law practice. But this article will cover some non–law-related apps that lawyers should incorporate into their daily work routine to increase productivity and improve recordkeeping.



MileIQ

MileIQ tracks your mileage and allows you to classify your

trips for business or personal. It is so easy to use because it works in the background so you never need to think about it. Just jump in the car and go. Then check the app later to categorize your trips, record your mileage, and record what each trip is worth.

With MileIQ, you can:

Classify your drives using default categories or develop your own;

View what each trip is worth or request a detailed report at any time, which is emailed to you immediately:

Track your trips for reimbursements and tax deductions. Personalize each drive, delete unwanted drives, duplicate drives, and more.

MileIQ is free for up to 40 drives per month, and only \$5.99/month for unlimited trips. It has a 4.6 rating in the Apple App Store, and a 4.5 rating in Google Play.



Evernote Scannable

Evernote Scannable is the most convenient and

easy-to-use app for scanning documents, such as receipts, business cards, contracts, briefs, checks, post-it notes, you name it. Scannable allows you to email a scanned document as a PDF or image, or save PDFs and images to your phone or cloud groups.

Scannable scans a document quickly and beautifully just by hovering your phone's camera over the document. You can even crop them in real time and resave. And there are no watermarks added to your documents and no prompts to upgrade after a certain amount of use.

Say goodbye to bulky, stationary scanners. PCMag.com named the app a PCMag Editors' Choice with 4.5 stars. The app has a 4.8 rating in the Apple App Store.



FAX by Alexey Bogdanov

The FAX app for Apple devices simplifies faxing

like nobody's business! What a way to prove that the monstrosity sitting in your office, better known as a fax machine, is no longer needed. This app will let you send any document anywhere, anytime. You can even combine multiple documents into a single fax and preview your fax before sending.

I downloaded this app after I received a form from my doctor's office, which needed to be faxed. At first, I considered firing up the old fax machine I still have in my office, until I realized that I had terminated the land line in my office months ago. I went searching for a solution and to my amazement, this app worked like a charm.

Send any file and import documents from your DropBox, Google Drive, or any cloud drive. You can even track your sent documents using the app.

The FAX app requires in-app purchases. You can buy 250 credits for about \$9.99. One page takes about 10 credits to fax, which is about .40 cents. TechRepublic.com recommends this app, which has more than 11,000 ratings, most of which are five stars. This app has a 4.8 rating in the Apple App Store.



DocuSign

With 50 million users, a 4.9 rating in the Apple App Store, and a

4.5 rating in Google Play, this app is worth a try. Use DocuSign to sign documents for free; but for a fee, you can also request signatures. You are limited to three free requests before you need to purchase different levels of access for a monthly fee. You can use email, Evernote, or any cloud drive to send documents.

DocuSign supports PDF, Word, Excel, and various image files, and it will notify you when a document has been signed.



Bitly

For many lawyers who are social media buffs and frequently

post on the go, the Bitly app is for you. Maintaining a social media presence is time consuming, so when this little app came along, it made capturing long URLs quick and simple when jumping on to Twitter, LinkedIn, or Facebook to post an event or a relevant article. Not only does Bitly shorten your links, it allows you to customize links, track clicks, and measure engagement. The app works great even though it shows only a 3.3 rating in the Apple App Store but a 4.3 rating in Google Play.

Remember, apps don't need to be designed solely for lawyers in order for lawyers to find them useful.

Energy for Your Work Day 5 Productivity Snacks

The three o'clock bewitching hour rolls around and your energy may be running low; however you still have a few more hours of work, a commute home, then your typical after-work activities (errands, running kids around, meeting up with friends, working out, etc.). Snacks that provide us with an endless amount of energy are a must. Below, I will lay out the top five productivity snacks to get you through your day. Whether you're driving to make an appointment, in and out of meetings, or "in-the-zone" at your desk, these snack selections will provide a convenient grab-n-go option no matter where you are.

Snack Choice 1: Rice Cakes with Peanut Butter and Fruit of Choice

Although rice cakes are a great low calorie option, they are a little more than refined carbohydrates (which are quickly digested and converted into sugar). That said, timing with rice cakes is key. Solely consuming rice cakes on an empty stomach can actually induce a spike in blood sugar. This might just leave you feeling sluggish and craving more foods. Try to pair rice cakes with a healthy fat and fruit choice. This will quickly switch over to one of the most convenient healthy grab-n-go snack options - especially pre workout. How so? When you pair a low calorie item (rice cakes) with fruit of choice (banana, apple, strawberry slices) and a healthy fat (peanut butter, avocado, hummus), the healthy fat will actually decrease hunger cues over time. Remember:

Snack smart. Grab 2 rice cakes and top with 1-2 tbsp. peanut butter and your fruit of choice

1/4 cup liquid egg whites or 1 whole egg

ing role in shaping our profession while we serve our members and our community," he said.

Having laid that groundwork, Truffer turned to the subject of lawyer assistance, an issue "which, if nothing else, will have a lasting impact as a result from my service as President." Citing a pair of recent "groundbreaking" studies that found the legal profession to be roughly three times more susceptible to stress-related alcohol and substance abuse, Truffer emphasized the need for destigmatization of this disease, and the expansion of resources available to those afflicted

by it

Using as a basis an August 2017 report issued by the American Bar Association's National Task Force on Lawyer Well-Being, Truffer noted that he has already initiated dialogue with various "stakeholders" throughout Maryland, including the MSBA Lawyer Assistance Program, the Maryland Judiciary, the Office of Bar Counsel, the Judicial Disabilities Commission, both of the state's law schools, and professional liability insurers.

"Each of these groups has a profound interest in combating the mental health issues of depression and alcohol and drug abuse which afflict many of Maryland's lawyers, judges, and law students," he said. "It is my goal for the MSBA over the next year, in partnership with these stakeholders, to develop for Maryland a coordinated effort, consistent with the recommendations of the ABA's National Task Force to acknowledge the problems of alcohol addiction and substance abuse and to promote awareness thereof; to expand the availability of treatment for these conditions; to destigmatize and encourage those who need treatment; and to emphasize the confidentiality of that treatment."

"To meet this challenge is both an act of humanity to those lawyers who need our help and critically necessary to meet our responsibilities to our community and to our profession," he summarized.

Truffer concluded by noting that MSBA has already "had to make many difficult choices as to its future course. In considering those decisions, there are voices among us who insist on looking backward, clutching on to what we have been, rather than looking to what we can be."

"With a full understanding

of our noble history and a deep appreciation for the contributions and sacrifices of so many who have made the MSBA the premier organization that it is, let me eliminate any ambiguity," declared MSBA's new President. "I stand with those who look forward – those who see change as an opportunity, rather than a peril."

Members also elected MSBA Officers for the 2018-2019 Bar Year, including: Dana O. Williams, MSBA President-Elect; Hon. Mark F. Scurti, MSBA Treasurer; and Deborah L. Potter, MSBA Secretary.
