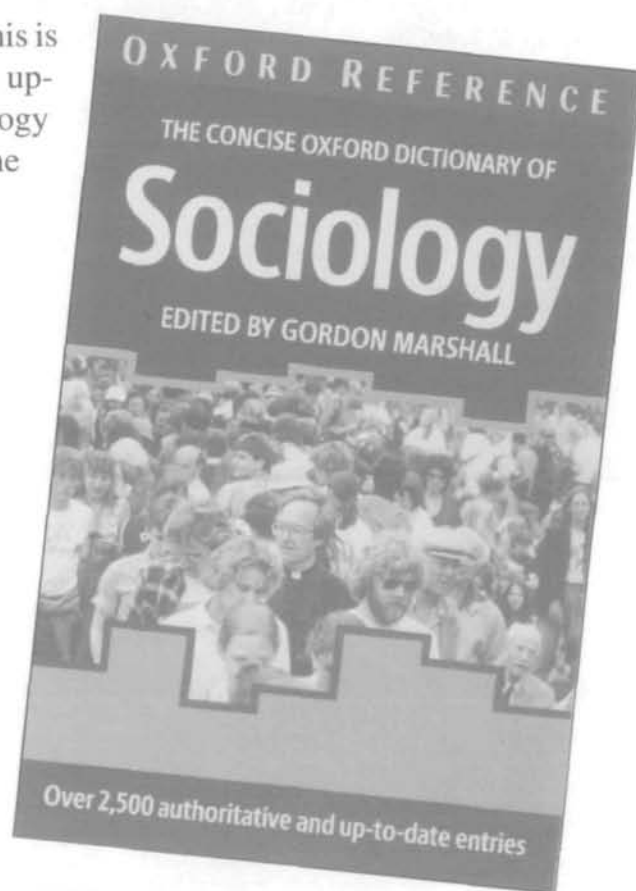

Notes on Contributors

Duane F. Alwin

Duane F. Alwin is Professor of Sociology and Program Director at the Survey Research Center of the Institute for Social Research, University of Michigan. He received a Ph.D. in sociology from the University of Wisconsin in 1972. He is mainly interested in the linkages between life-span human development, the family, and social change. His recent book (with Ronald Cohen and Theodore Newcomb), *Political Attitudes over the Life-Span: The Bennington Women after Fifty Years* (University of Wisconsin Press), is about attitude change and stability over the life-span.

Michael Braun

Michael Braun is Director of the German General Social Survey at ZUMA in Mannheim. He received his doctorate in sociology from the University of Munich in 1985. He is mainly interested in rational choice and research methodology and especially in international comparative research in the fields of inequality, work orientations, and the family.

Bogdan W. Mach

Bogdan W. Mach is a research fellow at the Institute of Political Science (Polish Academy of Sciences) in Warsaw, currently on leave teaching and doing research at the Johns Hopkins University in Baltimore. His theoretical and research interests focus on comparative social mobility and the relationship between social structure and personality. He has published *Social Mobility and Social Structure* (with Włodzimierz Wesółowski, 1987, London: Routledge & Kegan Paul), *Funkcja i działanie* (Function and Social Action: A Systemic Perspective on Social Mobility, 1989, Warsaw: Polish Scientific Publishers), and several articles. Recently he has been involved in international research projects on social stratification in Eastern Europe after 1989 and

the relationship between social structure and personality under the current conditions of radical social change in Eastern Europe.

Karl Ulrich Mayer

Karl Ulrich Mayer is Director at the Max-Planck-Institut für Bildungsforschung in Berlin and principal investigator of the German Life History Study. His research interests lie in the fields of social stratification and mobility and in the sociology of the life-course. His most recent publications are *Generationsdynamik in der Forschung* (1993, Frankfurt: Campus), *Vom Regen in die Traufe. Frauen zwischen Beruf und Familie* (edited with Jutta Allmendinger and Johannes Huinink, 1991, Frankfurt: Campus), *Lebensverläufe und sozialer Wandel* (1991, Opladen: Westdeutscher Verlag), and *Event History Analysis in Life Course Research* (edited with Nancy Tuma, 1991, University of Wisconsin Press). He is currently working on a monograph about the Berlin Aging Study and on a book about life courses in East Germany before and after Unification.

Michał Pohoski

Michał Pohoski is a professor of sociology at the university of Warsaw and the Dean of the Department of Philosophy and Sociology of that University. He has been a principal investigator of several waves of the Polish Life History Study. He has written books and monographs on rural-urban migration and prestige of occupations, and articles on social mobility and social inequality—e.g., 'Social Inequality and Social Mobility' (*International Journal of Sociology*, 16, 1986), and 'Evaluation of Incomes, Just Pay and Occupational Prestige' (co-authored by G. Lissowski, *Polish Sociological Bulletin*, 1, 1990). He is currently engaged in the analysis of several life-history data-sets from Poland.

Jacqueline Scott

Jacqueline Scott is Director of Research at the ESRC Research Centre on Micro-Social Change in Britain. She was formerly Director of the Detroit Area Study, University of Michigan. She received her Ph.D. in sociology from the University of Michigan. Her present research uses the British Household Panel Study for the analyses of social change in family relations, socio-economic values, employment attitudes, and psychological health. Recent publications include papers on collective memories, household formation and dissolution, and gender-role attitudes.

Yossi Shavit

Yossi Shavit is Associate Professor of Sociology at the European University Institute, and a Senior Lecturer at the University of Haifa. He is interested in social inequality and mobility regimes. He has also published on the educational and occupational stratification of ethnic groups in Israel and is currently studying (with Professor Vered Kraus) the transformation of Israel from an ethnic to a class society. He is engaged in an international comparative study of the role of formal education in shaping occupational opportunities. He has recently completed (with Hans-Peter Blossfeld) the integration of materials from a comparative study of change in educational attainment processes *Persistent Inequality: Changing Educational Stratification in Thirteen Countries* (Westview Press, 1993).

Haya Stier

Haya Stier is a lecturer in Sociology at the University of Haifa. Her interests are in the areas of marriage, divorce, labour-force participation, and gender stratification. She is working on a study of the Israeli marriage market (with Yossi Shavit), and on a book with Marta Tienda of the University of Chicago which documents work, welfare, and family behaviour of the poor of Chicago.

Sjerp van der Ploeg

Sjerp van der Ploeg studied sociology at the University of Groningen in the Netherlands. He graduated in 1988. From 1988 until 1992 he worked at Tilburg University on his dissertation about the expansion of secondary and tertiary education in the Netherlands. At the moment, he works at a private research institute, Regioplan Education and Labour-market, in Amsterdam.

Christopher T. Whelan

Christopher T. Whelan is a Research Professor at the Economic and Social Research Institute, Dublin. He is joint author of *Understanding Contemporary Ireland* (Macmillan, 1990) and joint editor with John Goldthorpe of *The Development of Industrial Society in Ireland* (British Academy, 1992). He is at present working on projects relating to the conceptualization and measurement of poverty, social mobility, working-class marginalization, and changing values in the Republic of Ireland.
