RE: Amendment to the Graduate School Bylaws

In accordance with Article X of the Graduate School Bylaws, adopted July 16, 1975, I am forwarding for Academic Senate review an amendment to the Bylaws as approved in a Graduate Faculty meeting, March 3, 1981.

The amendment is within Article X. The July 16, 1975 version reads as follows:

These Bylaws may be amended according to the following procedure:
(1) the amendment shall be submitted in writing to the Graduate Faculty; (2) the amendment shall be discussed at a Graduate Faculty meeting; and (3) the amendment must be approved at the subsequent regular Graduate Faculty meeting by a two-thirds vote of those present. Amendments to these Bylaws shall be subject to review by the Academic Senate.

The amended version as approved at the Graduate Faculty meeting reads as follows:

These Bylaws may be amended according to the following procedure:
(1) the amendment shall be submitted in writing to the Graduate Faculty; (2) the amendment shall be discussed at a Graduate Faculty meeting; and (3) the amendment must be approved by a two-thirds vote of those who respond within ten (10) school days to a special ballot mailed to all voting members of the Graduate Faculty. Amendments to these Bylaws shall be subject to review by the Academic Senate.
