### Please Help Us Reduce Paper Reports - Turn off printing of your BAR/BSR

Did you know that 80% of UW departments no longer receive paper versions of the BAR and/or BSR? If you still receive printed BAR/BSR's, you can opt out of printed BAR/BSR reports and help the University to achieve Washington State's paper reduction goals. All transaction data found on the BAR can be found in the MyFD Reconciliation Report, Transaction Summary Report or by running a MyFD Query. The information found on the BSR is available in the MyFD Budget Summary report, or, for multiple budgets, on a MyFD Budget List. MyFD reports allow users to access data online which is updated daily and meet records retention and audit requirements.

#### 2017 Payroll Load Rates Proposed

The proposed 2017 Payroll Load Rates (i.e., fringe benefit rates) have been published on the Financial Accounting webpage. These proposed rates reflect our current best estimate of fringe benefit costs to be incurred by the UW in fiscal year 2017 based on the state's 2015-2017 operating budget and the updated conference supplemental budget, which was released on March 28, 2016.

We are in the process of submitting these rates to the U.S. Department of Health and Human Services (DHHS) Cost Allocations Services office. While we do not anticipate any changes to the proposed rates, it is still possible for DHHS to come back and question anything we have proposed. We will communicate any changes to the proposed rates accordingly.

# **Equipment Capitalization Threshold Increase on July 1st**

After extensive consultation with campus partners, the Office of Research and Finance & Facilities will increase the equipment capitalization threshold from \$2,000 to \$5,000 on July 1st.

We would like to thank all of our campus partners including the Faculty Council on Research, the Research Advisory Board, Associate Deans for Research and Post-Award Administrative Advisory Group who participated in the decision making process.

# **Partnership for Records Transformation**

Since the first steps were taken in 2009, Records Management Services has been a partner in bringing an Enterprise Document Management System (EDMS) to the UW. Now called UW-IT CONCERT, EDMS is a UW-IT centrally supported platform for digitizing, storing and managing records to automate paper-based business processes. For records retention, this platform makes it easier to search, identify and hold records responsive to public records requests, litigation, and audit, and to identify and approve the purging of records at the end of their legal retention period. Merchant Services support will be moving from Student Fiscal Services to Banking & Accounting Operations in Financial Accounting over the next several months. out to campus departments for additional information regarding their credit card processing. In particular, with new and more complex requirements, we will be undertaking an effort to identify any gaps in PCI (Payment Card Industry) compliance.
