Davidson County Community College Healthcare Interpreting Certificate Continuing Education Frequently Asked Questions

Certificate Option Description – This certificate option is comprised of a series of three online courses – Medical Terminology for Interpreters, Introduction to Interpreting in a Healthcare Environment, and Cultural Health Habits. Students who complete all of the courses and are at least 18 years old will be prepared to take certification exams offered by the National Board of Certification for Medical Interpreters (NBCMI) and the Certification Commission for Healthcare Interpreters (CCHI). Completion of the Certificate in continuing education would prepare students who are at least 18 years old to meet the education requirements to test for both certifying bodies.

NOTE: A person must be at least <u>18 years of age</u> and have obtained a <u>GED/high school diploma</u> in order to sit for testing for either of the two national certification exams.

How do I enroll in this program? -

- 1) Complete the program interest form that is included in this packet and submit to Public Safety Building room #112.
- 2) Provide proof of a high school diploma or transcript/GED.
- **3)** Provide proof of either college credit for English or college level reading score on placement test taken within the last five years.
- **4)** Take the Spanish Language Assessment and meet benchmark of at least 60. **Note:** All students are required to take the Assessment.

Reading Placement testing: Students must be reading at college level in order to be successful in the courses. To meet this requirement, students can sign up to take placement testing at DCCC or at their local community college. If students have already completed college courses or a degree, students may submit an unofficial transcript to be considered in lieu of placement testing.

Spanish Language Assessment: This Spanish language assessment is to determine proficiency in Spanish. <u>All students are required to take the Assessment</u>. To schedule, contact the Learning Commons at DCCC: 336-249-8186 ext. 6787. For distance students, testing arrangements can be made – contact staff at DCCC for more information.

How do I register? Submit all paperwork to Diane Hedgecock, Public Safety Bldg. #112. Once the information has been submitted and verified, students will receive a letter of eligibility with course codes and can contact ConEd Registration at 336-224-4545 or in person on the 2nd floor of the Brooks Student Center to register.
