District 2 Update

Dear Neighbor,

As we enter March and tackle a new set of opportunities for the month, I'd like to give a quick update on a couple regional plans the Second District has been working on:

- The Southern California Association of Governments (SCAG) Regional Council met at the beginning of the month to discuss and "receive and file" the Regional Housing Needs Assessment (RHNA) numbers which was updated to reflect additional requests made by the City of Los Angeles' as part of the original decision made last November. There was a strong showing from the Orange County bloc to challenge the RHNA numbers (which increased the Orange County regions mandated unit count to approximately 75,000 units) and to some extent, even challenge the validity of the vote we took in November. Although the challenge failed to produce any headway, it will be interesting to see what gets brought up at this month's meeting when the Regional Council meets to "Finalize" the RHNA numbers.

- Last month we met with the Santa Ana River Conservancy Local Advisory Group which is comprised of state, county and city elected officials, various conservation and non-profits groups, along with the local Parks and Recreation Districts to discuss connecting the Santa Ana River trail to traverse Orange County, Riverside County and San Bernardino County and the surrounding cities. While this goal seems simple enough, we all know the complexities of local government. We will keep you posted as this Advisory Group progresses.

Water Efficiency Laws - Senate Bill 606 and Assembly Bill 1668

On May 31, 2018, then Governor Brown signed two bills (SB 606 and AB 1668) which emphasized water efficiency and to stretch existing water supplies. In the last several weeks there were several news media reports providing inaccurate information regarding these two bills. Some of the inaccurate information spread online were that you could not "take a shower and do laundry on the same day" or the individual would be fined.

Below are facts on the long-term water efficiency legislation that was signed into effect in May of 2018:

- Water agencies are required to calculate a water efficiency standard for their entire service area annually based on indoor residential water use; outdoor water use; and commercial, industrial and institutional irrigation.
- The standard of 55 gallons per person per day for indoor residential water use is not intended as an enforceable standard for individuals. It is one of several elements used to calculate the overall efficiency standard for a service area.
- Individuals will not be responsible for State Water Resources Control Board fines. Instead, the State Water Board can fine water agencies up to \$10,000 per day if the agency does not meet its cumulative standard.
- There is no law against showering and doing laundry on the same day. There are no specific statewide laws that require individual households to meet any specific targets. The targets will be set for the water provider and are scheduled to go into effect in 2023.

Prospect Avenue in Highgrove

Sometime in late December, we received several phone calls from surrounding neighbors in the Highgrove area who complained about a property that was being used as a possible homeless encampment. The property had trash and debris piling up within the property and potential homeless individuals living on or within the surrounding property. We worked with the Riverside County Transportation Land Management Agency (TLMA) which includes the Riverside County Code Enforcement Department to conduct an investigation into the matter. Ultimately, the completion of review by Riverside County Code Enforcement Department concluded that a seizure warrant be issued through the courts for Accumulated Rubbish and Excessive Outside Storage. Within the last week or two, a seizure warrant was signed by a judge and a contractor was scheduled and completed cleanup of the property.

We want to give a HUGE thank you to our TLMA and Code Enforcement staff for working tirelessly to address the needs of the Highgrove neighborhood and score a BIG win for the neighbors!



Just the facts: correct information on California's new water efficiency laws

RIVERSIDE, CA – Earlier this month, news media reports provided inaccurate information regarding water use targets set by Senate Bill 606 (Hertzberg) and Assembly Bill 1668 (Friedman).

On May 31, 2018, Governor Brown signed two bills which build on the ongoing efforts to “make water conservation a California way of life.”

Neither bill sets fines on water customers for taking a shower and doing laundry on the same day. Instead, the adopted legislation emphasize efficiency and stretching existing water supplies as reported by local media.

“The adoption of Western’s tiered rate structure in 2011 has put the District in a very good position to comply with the new legislation without any changes,” said Western’s General Manager Craig Miller. “As always, Western continuously promotes water efficiency and provides education programs and rebates for our customers, allowing them to stay within budget and reduce their water bill.”

Below are facts on the long-term water efficiency legislation that was signed into effect May 2018.

- Water agencies are required to calculate a water efficiency standard for their entire service area annually based on indoor residential water use; outdoor water use; and commercial, industrial and institutional irrigation.
- The standard of 55 gallons per person per day for indoor residential water use is not intended as an enforceable standard for individuals. It is one of several elements used to calculate the overall efficiency standard for a service area.
- Individuals will not be responsible for State Water Resources Control Board fines. Instead, the State Water Board can fine water agencies up to \$10,000 per day if the agency does not meet its cumulative standard.
- There is no law against showering and doing laundry on the same day. There are no specific statewide laws that require individual households to meet any specific targets. The targets will be set for the water provider and are scheduled to go into effect in 2023.

“Western staff is participating in all of the State’s technical working groups to develop implementation plans for agencies’ water use targets,” continued Miller.






