LICENSE AGREEMENT

This License Agreement is made this __11th __day of May, 2021, by and between the Town of Oak Bluffs, Massachusetts (the "Town"), and the Unites States Coast Guard ("USCG")

Whereas, the Town is the owner of a parcel of land located on Each Chop Drive in the Town, identified on the Town's Assessor's Map 2, as Lot 3, which land serves as a public park (the "Town Parcel");

Whereas, the USCG owns and/or controls a parcel of land situated in or surrounded by the Town Parcel and which is improved by an active Lighthouse (the "Lighthouse"), identified on the Town's Assessor's Map 2, as Lot 4 (the "USCG Parcel");

Whereas, both parcels are shown on site plan attached hereto as Exhibit A;

Whereas, the USCG has determined that certain substances from the Lighthouse have leached into the surrounding area, including, in all likelihood, the Town Parcel;

Whereas, the USCG desires to undertake efforts to determine the scope of the infiltration of any toxins or other substances into or on the Town Parcel;

Whereas, the Town desires that the USCG take certain steps to determine the scope of the infiltration, if any, and the USGC has requested permission to enter the Town Parcel to conduct limited studies, in connection with a USCG effort to remediate the Town Parcel, if necessary;

Now, therefore, in consideration of \$1.00 and the mutual promises and covenants contained herein, the receipt and sufficiency of which is acknowledged, the Town grants the USCG permission to enter the Town Parcel on the following terms and conditions:

- 1. The Town grants the USCG, its successors, assigns, and agents a license to enter the Town Parcel through August 31, 2021, for the purposes of conducting sampling of portions of the Town Parcel to determine the scope of lead contamination.
- 2. The USCG agrees, at its expense, to use reasonable efforts to restore the Town Parcel to its natural state prior to any sampling and to cause as little damage to the natural terrain as possible.
- 3. The license granted herein may be terminated by the Town at will, it being understood and agreed that said license is revocable, and that the Town may terminate it for any reason or for no reason.
- 5. It is agreed that any notice terminating this license by the Town shall be mailed by first-class to the USCG at address provided by it within three business days of the provision of this license. The USCG will furnish that address to the acting Town Administrator at wbrough@oakbluffsma.gov.

- 6. The USCG agrees to give forty-eight (48) hours notice before commencing any work to the acting Town Administrator at wbrough@oakbluffsma.gov.
- 7. Subject to the Federal Torts Claims Act, 28 U.S.C. §§ 2671 2680, and the Antideficiency Act, 31 U.S.C. § 1341, the USCG agrees to indemnify and hold the Town harmless from any and all claims arising from the work authorized by this license.
- 8. The USCG agrees to report its findings to the acting Town Administrator within a reasonable time after completing its sampling and exploratory work, but in no event more than thirty (30) days after completion.
