

Bibliographic references that are written directly **in the text** have to be written by the author name followed by a comma, then by a space and the year of the first original publication between brackets – “Freud (1899) said that...” – or with the surname of the author between brackets followed by a comma, a space and the year – (Freud, 1899). For literal quotation the page has to be indicated written in brackets after the year of publication and preceded by a “p.” (Loewald, 1980, p.56 ed. orig.). If there are different publications by the same author in the same year, the year is followed by lower case letters in alphabetical order.

The difference between “and” and “&”:

If there are two authors, both of them have to be written and connected by “and”, that can be used even to connect the last two authors when there are three of them. If the authors are more than three, only the surname of the first has to be written, followed by *et al.* (in italics because it is latin: *et alii*).

- “and” is used when the authors are cited outside brackets;
- “&” is used when the authors are in brackets.

Examples:

- Lavanco e Novara (2002)
- (Lavanco & Novara, 2002)

*Use of *ivi* and *ibidem**

The abbreviations *ivi* o *ibidem* have to be written in italics and between brackets for a bibliographic reference in the text to point that the quotation is the same of the precedent. The choice between the two involves a distinction:

- when in the former quotation the page of reference is cited *ibidem* is used when the quotation is of the text and the page;
- *ivi* is used when there is a reference on the former quotation regardless of the content of the quotation and of the presence of the reference pages (if in the former reference there is a quotation with pages then it is clear that the new citation with *ivi* directs to different pages of the text).

Bibliographic references at the end of the text have to be reported at the end of the article, with an hanging indentation (0,5 cm) and single interline; between a reference and the other it has to be inserted a space of 6pt. References have to be listed without numeration, at the end of the text, in alphabetical order following the surname of the first author and, for each author, in the chronological order of publication (if there are more reference with the same author and year of publication the indications a, b, and c have to be used). If the name of the author consists of two names (with a middle initial), the two initials have to be reported without a space (for examples: Bianchi, G.A., Rossi, P.F., Kernberg, O.F.).

If the work has different authors, all the surnames have to be written.

A good practice is to write only the references written in the text.
